Should we call Brad Wall a liar?

New revelations that Saskatchewan Premier Brad Wall is aggressively pursuing the privatization of SaskTel, makes it increasingly difficult to conclude that he was truthful during the 2016 election.

"Brad Wall misled voters," said Jerry Dias, National President. "If the Sask Party wants to dismantle

public services and sell off Crown corporations that took generations to build, it should have the decency to run an election on the issue."

During the last Saskatchewan election campaign, Wall promised the CBC in writing that no Crown corporations covered under the Crown Corporations Act would be

Rebuilding a **NAFTA** for workers

As the first round of talks to revamp the North American Free Trade Agreement (NAFTA) approach Unifor is calling for a massive overhaul of the trade deal.

"International talks on trade have to go beyond a tweak here and a little change there," said Jerry Dias, National President. "What we need is a fundamental change in the way our governments approach trade."

A joint Unifor-UAW statement on auto and the re-negotiation of NAFTA blames the pact for the loss of hundreds of thousands of jobs and the closure of thousands of U.S. and Canadian manufacturing facilities. The unions warn that "NAFTA renegotiations will only be successful if it leads to higher wages in all three countries, reverses trade deficits with Mexico, and creates new manufacturing

IMF says Trudeau government can do more on child care

Justin Trudeau arrived in Nova Scotia on July 21 as part of a 'working holiday' tour to promote and discuss several issues, both regional and national, including the Liberals' Canada Child Benefit. The program, implemented last year, is something he spoke of with pride, but has faced criticism from child care experts and most recently the International Monetary Fund (IMF). Researchers at the IMF concluded that the Canadian federal government can afford to spend \$8-billion annually to directly reduce the cost of child care spaces nationwide because the

itself. Parents who can access quality, affordable child care are more likely to re-enter the workforce, thus contributing income tax dollars back into the government coffers.

"Leading authorities and international best practices have been showing us for years that a universal program where quality spaces are made accessible and affordable will do the most to support Canadian families," said Lisa Kelly, Director of the Unifor Women's Department. "The IMF isn't exactly radical. So when they are calling for public investment, we know our government can be doing a lot more."



The proposal suggested by the IMF study is more than 10 times the amount the Liberals plan to invest in child care over the next decade and it would bring the cost of child care fees down by about 40% - a number that would be expected to allow more parents, particularly women, to re-enter the workforce.

jobs in the U.S. and Canada."

The joint union statement, found online at unifor.org/NAFTA, also outlines four key priorities in the re-negotiation of auto-related provisions:

- Strengthening labour standards and raising wages,
- Balanced trade,
- Real "made in North America" rules, and
- A fair share of benefits for workers in each country.

In preparation of NAFTA talks with the United States and Mexico, to be held in Washington, D.C. from Aug. 16-20, Unifor has also provided written recommendations that go beyond the auto industry in a submission to the federal government.

Key Unifor

recommendations include enforceable labour and environmental standards, elimination of the right of corporations to sue governments over lost profits, an overhaul of rules governing auto trade across borders, and measures to protect our food supply, cultural industries, and public services such as health and education. "These recommendations will help ensure there is a different kind of policy approach to NAFTA and all future trade deals. It's about time that trade helped not hindered workers and

communities," Dias said.

International trade strategy will be discussed and debated at the upcoming Canadian Council as Unifor prepares to implement its plan of action on trade. National President Jerry Dias will also bring a multi-pronged recommendation on trade to the floor for delegates to consider.

privatized. But six months after winning re-election, the government amended the Act enabling up to 49% to be sold off to private interests.

More recently, Crowns Minister Dustin Duncan was forced to admit that backroom talks are underway to privatize Sasktel.

The birthplace of publicly-owned utilities, Saskatchewan's many Crown corporations are both successful and popular. The publicly owned services save residents money every day on costs like energy and phone bills. Other core public services like hospitals and schools are partially funded through dividends received from the Crowns. Equally important, Crown corporations are a source of good union jobs in the province.

"Brad Wall has no mandate to sell off public assets that generate millions for the people of Saskatchewan," said Joie Warnock, Western Regional Director. "Selling-off Crown corporations would be a disaster for the long-term health of hospital and school funding."

Among other sectors, Unifor represents thousands of Crown corporation workers at SaskTel, SaskEnergy, SaskPower, and SaskWater.

Unifor donates over \$220,000 to BC relief

On July 12, Unifor responded to the wildfire crisis in BC's Interior with a \$100,000 donation to the Canadian Red Cross relief efforts. Unifor's regional councils have added another \$120,000 in donations, and on July 28 the Western Regional Office held a BBQ to raise additional funds bringing the total donation to well over \$220,000.

"Unifor members have been following the devastation caused by the fires very closely and we feel compelled to act," said Jerry Dias, National President. "I encourage every Unifor member and all Canadians to make a donation to the Red Cross so that the affected families can rebuild and recover."

Unifor has several hundred members spread out across the affected area, including 100 Mile House, 150 Mile House, Dog Creek, Lac La Hache, Quesnel, Soda Creek, Wildwood, and Williams Lake.

"I want BC residents, Unifor members, and their communities to know that we want to do everything we can to support them during this traumatic time," said Lana Payne, Atlantic Regional Director.
